A. YTD Financial Review

Tessin reported that all budget items are on track. MMWA received an additional \$12,874 from the Saginaw County Health Department's unused Solid County Solid Waste Fund monies.

A. Proposed 2022 Executive Committee Slate

Chair Taylor reviewed the recommended Executive Committee slate.

C. MMWA Request for Proposal (RFP) Solid Waste Services Review

Tessin reviewed the recommended timeline for the RFP process and advised a special call Board of Trustees meeting to approve the RFP document is planned for January 10, 2022. Tessin then walked members through the RFP companion piece. Members discussed the timeline. Taylor defined next steps including recommending that each Trustee and Alternate Trustee review the RFP and submit any questions to Tessin before the special call meeting on January 10, 2022.

VIII. Program Items: Information &/or Approval

A. Proposed 2022 Special Waste Drop Off Schedule

Tessin explained that there will be five all in one drop off events in 2022 beginning in May and running through September including one weekday and four Saturday dates. Shred events have been reduced from four hours to two hours in recognition of the limited demand.

Motion by Tittabawassee Twp/Metiva, seconded by Richland Twp/Reno, to approve the 2022 special waste drop off schedule as presented.

B. 2021 Special Waste Season Update

Tessin reported MMWA held six all-in-one events between May and September and two shred events. Events were well attended and a significant volume of hazardous waste was diverted from the landfill.

C. 2021/2022 Holiday Light Program

Thayer reported on MMWA's seventh annual Holiday Light Drive program. Residents can drop off broken, old, and out of style lights at fifteen locations in Saginaw County and one location in Gratiot County. The program began on November 15, 2021 and runs through January 15, 2022. Proceeds with benefit the CAN Council.
